The subscription service is valid for one (1) year following receipt of payment for the service. There is no maximum number of ambulance transports during the period covered.	3. The subscription service covers one-way, emergency transports to one of the hospitals the ambulance routinely transports to. These include; Maine Medical Center, Portland; Mercy Hospital, Portland; Southern Maine Medical Center, Biddeford; Goodall Hospital, Sanford; and Northern Cumberland Memorial Hospital, Bridgton.	The subscription service only covers ambulance services made by Limington Fire and EMS.	The subscription service only covers the balance of charges incurred for ambulance services not covered by insurance. All monies received from the members insurance for ambulance transportation must be forwarded to the Town of Limington.	Federal law does not allow the service to write off insurance deductibles. We reserve the right to bill third party payers.	 Members that belong to an HMO that requires prior approval for service are responsible for obtaining that approval. 	8.
