Putting the Transfer Station under the PWD will hopefully ensure that we can get the roll offs and compactor emptied on a more timely fashion to help with recycling, and hopefully allow the Transfer Station to reduce tipping fees and maybe extend hours.

The Limington Select Board will go into Executive Session on March 01,2023 at 2:00 p.m. pursuant to 1 M.R.S.A. § 405(6)(A) to discuss personnel matters.
