Meeting with residents about road concerns on Dole's Ridge Rd, the speed limit and center line in the road. Stanley Hackett spoken with Rady Lillian of DOT and he has suggested the town add curve warnings and reduce speed signs.

Residents asked about the guard rails on Dole's Ridge, Boothby, and Cape Rds, the DOT has said that they are having materials and labor issues, but project the end of August for repairs.

Met with the OTH Committee about renovations and proposal submitted by Rick Irons.

Questions for MMA about insurance extension and additional funding for project. Spoke with a second bidder, Bickford and have asked him to present an updated proposal to the Old Town hall Committee Tuesday July, 05, 2022. The Select Board will be placing an add about a public hearing about the OTH bids and renovation work.
